## How to Track Civil Rights Complaints Made to the EPA

- The EPA maintains a <u>docket tracking complaints</u> under Title VI of the Civil Rights Act, which typically concerns environmental racism. It was last updated 3/24/2025.
- As the federal government moves to delete federal data, Sentient has created a copy of the EPA's docket of complaints under Title VI of the Civil Rights Act, spanning between 2010 and 2025, available <u>as an editable</u> <u>zip file</u>, or <u>a viewable Google Sheet</u>.
- Journalists, advocates and others interested in tracking civil rights can freely download our copy of the docket.
